On 02/06/12 at approximately 1413 hours, I responded to 1540 Retreat View Cir in reference to a burglary. Upon arrival I made contact with Tatiana Deamicis (victim), who provided a sworn written statement of the following information:

On 02/06/12 at approximately 1410 hours, Deamicis returned to her residence (1540 Retreat View Cir) and noticed that the screen was missing from the front kitchen window and that the window was open (entry point). She then noticed that her sliding glass door in the rear of the residence was also open (exit point). Deamicis then went up stairs to her bed room and saw that her laptop (Macbook Pro computer modal number A1278, serial number WQ022R5PATM. Value \$3000.00.) was missing along with a gold neckless from the dining room table. Deamicis did not see any one break into her residence or take any items. The last time Deamicis saw her residence untouched was on 02/06/12 at approximately 1230 hours. Deamicis advised that no one had permission to break into her residence or take any belonging and she wants to press charges. It should be noted that there was no forced entry, due to the fact that Deamicis left her kitchen window unlocked.

I then made contact with Iain Beard and Arnold Arms (witnesses), who both provided sworn written statements of the following information: Beard and Arms both stated that on 02/06/12 at approximately 1400 hours, they saw a black male adult (wearing a black shirt, blue jean shorts, and black shoes) in the area of 1540 Retreat View Cir. They described the black male as being in his mid 20's, standing about 5'08" and weighing approximately 180lbs. Beard advised that he believed the black male to be the same person who stole his bicycle (Sanford case number 201250000485). They said that they saw the black male standing next to 1540 Retreat View Cir, however they did not see him break into the residence.

I processed the scene for print and was able to lift some (JB-1). The prints were turned into the Sanford Police Department for evidence. There is no further information at this time. This case is being forwarded to general investigations for further review.

On 02/07/12 at approximately 1300 hours, I responded to area of 1540 Retreat view Cir in reference to a group of suspicious person(s). Sanford Dispatch advised that there were four males on bicycles in the area, that one of them was possibly a suspect in this case.

Upon arrival myself and Ofc. M. Hickley made contact with three black males and one white male on bicycles in a cut through area of the complex (a grass area were Retreat at Twin Lakes backs up to Colonial Village Apts). The white male had on a white t-shirt and jeans (██████████), one black male had on a black shirt and black beanie cap (██████████), the other black male had on a red hat and red shorts (██████████), and the last black male was wearing a black shirt, black jacket and jean shorts and black shoes (██████████).

Ofc. L. Rivera then arrived on scene; while he and Ofc. Hickley were checking the identifications of the subjects, I made contact with the caller Arnold Arms and Iain Beard. Arms and Beard both stated that the black male wearing the black jacket, black shirt, jean shorts, and black shoes (██████████) was the same black male they saw in the area of 1540 Retreat View Cir on 02/06/12. They also provided a sworn written statement advising that Burgess was wearing the same cloths that he was wearing on 02/06/12.

While Ofc. Rivera and Ofc. Hickley were trying to verify the identify of (██████████) (he original gave a false name), I asked Ransburg if I could look through his back pack that he was carrying. Ransburg gave me permission to look through his back pack, to which I found two laptop

computers. One of the computers was an Apple Macbook Pro, I then asked Ransburg if the Apple computer belonged to him, to which he replied no. It should be noted that with out any hesitation [REDACTED] told me that the Apple laptop was his computer and that he had bought it last night. I then ran the serial number on the Apple computer (WQ022R5PATM) through FCIC/NCIC. The computer came back stolen out of Sanford and came back to this case number. The other computer came back with negative results at this time.

Myself, Ofc. Rivera, and Ofc. Hickley then tried to hand cuff all of the subjects, however [REDACTED] took head long flight, and ran through the Colonial Village apartment complex. Ofc. Hickley and myself secured the other subjects, while Ofc. Rivera gave chase on foot after [REDACTED]. A short time later Ofc. Rivera advised that [REDACTED] had been apprehended in the Colonial Village apartment complex.

Inv. Foshee was notified and arrived on scene. I turned over the Apple Macbook Pro laptop computer to Inv. Foshee and transported [REDACTED] to the Sanford Police Department for questioning.
