

**FLORIDA DEPARTMENT OF LAW ENFORCEMENT
INVESTIGATIVE REPORT**

On Thursday March 15, 2012, the Florida Department of Law Enforcement (FDLE) received a request for assistance from Norm Wolfinger, State Attorney for the Eighteenth Judicial Circuit, requesting that FDLE assist their office with an inquiry into the February 26th 2012, shooting death of Trayvon Martin.

On Monday, April 2, 2012, at approximately 0819 hours, SA Moore received a call via cell from SAS Susan Kuhn providing instructions to call Assistant State Attorney (ASA) Bernie De-La-Rionda of the Duval County State Attorney Office (DCSAO). SA Moore made contact with ASA De La Rionda who provided limited information but requested assistance with an interview in the Miami-Dade and Broward County areas. ASA De-La-Rionda stated he would be arriving via American Airlines with an Investigator at approximately 1045 hours at the Miami airport. SA Kristin Hoffacker was also assigned to assist with the detail and coordinated with Miami-Dade Police Department (MDPD) airport units to facilitate their arrival. The flight arrived approximately 1230 hours with ASA De La Rionda and SAO Investigator T C Osteen.

SA Moore was briefed by ASA De-La-Rionda once inside the vehicle and enroute to the northeast area of Miami-Dade county. It was advised that a statement would be taken from Sybrina Fulton; mother of Trayvon Martin, Tracy Martin; father of Trayvon and [REDACTED] Trayvon's girlfriend. This interview will take place at [REDACTED] but [REDACTED] possibly lived in the [REDACTED]. The address was relayed to SA Gaylon White in an effort to conduct a surveillance to assure no media was in the area.

Upon arrival at the location, we were met by attorney Benjamin Crump and later by attorney Daryl Parks and attorney Natalie Jackson, who works with Parks and Crump. Sybrina Fulton arrived and a statement was taken by DCSAO members at approximately 1540 hours. Tracy Martin arrived later (approximately 1630) and subsequently gave a statement to DCSAO. At the completions of the statements by DCSAO, an attempt was made to locate [REDACTED] at [REDACTED] which met with negative results. A secondary attempt was made at [REDACTED] in the [REDACTED] of Broward county where [REDACTED] was located at approximately 1830 hours. [REDACTED] volunteered to be escorted to Sybrina's residence [REDACTED] where she gave a statement to DCSAO members. [REDACTED] was subsequently returned to [REDACTED].
