**SCHEDULING ORDER AND ADMINISTRATIVE PROCEDURES TO BE FOLLOWED
BEFORE TRIAL**

THIS CAUSE came before this Court upon its own motion, after discussion with counsel in open court on October 26, 2012. Upon the agreement of the parties, the following deadlines shall apply.

It is hereby **ORDERED**:

1. Trial is presently set to begin on June 10, 2012.
 - a. Any Self-Defense Immunity / Stand Your Ground motion shall be filed and heard on or before April 26, 2013, which is 45 days before trial.
 - b. Final witness lists, including any expected expert witnesses, shall be exchanged on or before March 27, 2013, which is 75 days before trial.
 - c. Any other pre-trial motions shall be filed and heard or before May 10, 2013, which is 31 days prior to trial.
 - d. Certain short-matter motions addressing purely legal matters may be heard on or before May 31, 2013, which is 10 days prior to trial.
 - e. No continuances of the trial will be granted on the basis that the parties have not complied with these deadlines.
2. Courtesy copies of any documents or memoranda relating to a motion hearing shall be provided to this Court no less than 48 hours before the

hearing if the parties wish for this Court to consider the information within those pleadings.

- a. Such documents may be faxed to the Court if they contain no more than ten pages.
 - b. Emailed documents will not be accepted by the Court.
 - c. Pleadings containing more than ten pages shall be hand delivered to the court.
 - d. This provision only addresses courtesy copies for this Court. The parties shall comply with the Clerk of the Court's filing procedures for filing record documents.
3. No less than 48 hours before a hearing date, a Notice of Hearing reflecting all motions to be considered by the Court shall be provided by the moving party.
 4. The next scheduled court date is December 11, 2012 at 9:00 a.m.
